**Notice & Instructions for Application**  
**Empanelment for the Ad-hoc Panel (History)**

This is with reference to the earlier notice issued on 15<sup>th</sup> April 2021 for empanelment in the Adhoc Panel for the posts of Adhoc Assistant Professor in History in the constituent Colleges of the University of Delhi for the academic session 2021-22. That notice was subsequently withdrawn due to severe Covid-19 pandemic conditions prevailing in the country at that time.

Now the online applications are invited for the above-mentioned purpose from all interested candidates. The department is aiming to coalesce and renew all the existing and multiple data bases available with it, thus all the interested candidates are requested to apply afresh within the period from June 11<sup>th</sup> – June 30<sup>th</sup> 2021 via the proforma provided below.

**Please read the following instructions and Eligibility conditions carefully before applying:**

1. Applications are invited from all the candidates who fulfill the minimum eligibility requirements as laid down by the UGC Regulations 2018/University of Delhi rules. **They must submit their application along with all the necessary self-attested documents mentioned in the Google-Form.**
2. **All applicants**, including those who having their names in the existing panels already or who had earlier applied by post, are **required to apply afresh**. With the issuance of the new Adhoc Panel prepared on the basis of the online Google- form, applications received within the period from **June 11<sup>th</sup> to June 30<sup>th</sup> 2021**, all the existing Adhoc Panels in History will automatically lapse. **Therefore, it is mandatory for every candidate to apply again.**
3. Please note – **ONLY use the Google form (Link given above) to fill your application**. Otherwise your application will be out rightly rejected. The last date for receiving online application form is **30<sup>th</sup> June, 2021, until 5:00 PM (Evening)**. No late entries will be entertained and onus of providing valid documentary proof lies on the applicant.
4. **Criteria for allotment of categories (as specified by University Rules and Regulations) will be as under:**

S.No.	Qualification to be taken into consideration	Category
1.	First division from graduation onwards + Ph.D.	I
2.	First division at the graduation level or P.G level + Ph.D.	II
3.	Graduation first division + P.G. first division + NET Qualified	III
4.	First division either at the graduation level or P.G. level + NET qualified	IV
5.	Graduation & PG second division (Minimum 55% [50% for candidates belonging to SC/ST] ) + Ph.D.	V
6.	Graduation & PG second division (Minimum 55% [50% For candidates belonging to SC/ST] ) + NET qualified	VI

6. ALL applicants must submit either a NET certificate or a NET exemption certificate from their RESPECTIVE Departments. Candidates, who have been awarded a Ph.D Degree in History in accordance with the University Grants Commission (Minimum Standards and Procedure for award of PhD Degree) Regulations 2009, shall be exempted from the requirement of NET, subject to their production of an appropriate certificate in this respect. The FORM REQUIRED OF RESEARCH SCHOLARS IS APPENDED AS ANNEXURE 2. If your university provides a different, less comprehensive statement, please submit that form together with ALL the supporting qualifications required by the University of Delhi. This includes a copy of your degree, copies of your two published research papers and proof of two presentations in conferences/seminars.
7. Candidates registered for the Ph.D prior to 11th July, 2009 are governed by the provisions of the then existing ordinances/Bye Laws/Regulations of the Institutions awarding the degree. Such PhD degree holders shall be exempted from the requirement of NET, subject to the production of an appropriate certificate indicating the following:
  - A. That the PhD Degree of the candidate was awarded in the regular mode.
  - B. That two external examiners did the evaluation of the Ph.D thesis.
  - C. That an open Ph.D viva voce examination of the candidate was conducted.
  - D. That the candidate has published two research papers based on his/her Ph.D work out of which at least one was in a refereed journal. If your certificate does not specifically acknowledge this, then please supply copies of the publications.
  - E. That the candidate had made at least two presentations in conferences/seminars based on his/her Ph.D. work. If the certificate does not specifically acknowledge this, then please supply proof of these presentations.
8. Candidates who have obtained their PhD in the concerned subject from a foreign University that is among the top 500 in the World University Ranking according to QS, THE or the ARWU (see Gazette of India, July 18, 2018, p. 60 for details) have NET exemption.
9. As per the UGC Regulations, (Clause 3.10) July 2018 and DU amendments to Ordinance XXIV (E.C Res. No. 8-8 dated 01-02.07.2019) the Ph.D. Degree shall be a mandatory qualification for the post of Assistant Professor in Universities with effect from 01.07.2021.
10. If any condition changes because of the UGC and University of Delhi rules and regulations regarding the qualifications required for empanelment as Ad-hoc/Guest Assistant Professor in the Departments of History of the constituent Colleges of University of Delhi, a notification will be put up and subsequently the Adhoc panel will be revised accordingly. The revised panel, if any, will also be put up on the website. No individual email will be sent or entertained separately in this regard.
11. It should be noted that incomplete applications – those that are without all the supporting documents or do not meet the UGC/DU RULES OR HISTORY DEPARTMENT CRITERIA– will not be accepted and rejected without any explanation. The Department reserves the right to reject the application, even if the candidate has been a part of the previous adhoc panels. No appeal against such rejection will be entertained. Thus the responsibility of submitting the correct information and all the relevant documents/certificates lies entirely on the candidates.
12. The candidate must ensure that the **online form has been filled only once.**


