BIDDERS ARE REQUIRED TO GO THROUGH THE SAME BEFORE SUBMITTING THE TENDER.

1. The Tenders should be submitted in sealed covers. Late/delayed & tender received without Earnest Money Deposit (EMD) in shape of Demand Draft (DD) shall not be acceptable at all.
2. The Vehicle is offered for disposal on "**AS IS WHERE IS BASIS**". Taxes and duties if any that may be **levied by government** will have to be met by the buyer.
3. The bidders may inspect the above vehicle on any working day from 09/03/2021 to 22/03/2021 between 10.30 a.m. to 05.00 p.m. No complaint whatsoever will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.
4. The offers given in the valid Tenders received within due date and time and accompanied with the required amount of EMD only will be considered.
5. EMD of the unsuccessful bidders will be returned after finalization of the award to successful bidder. EMD of the bidder who fails to honor the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Institute. EMD will not be adjusted in the sale Amount accepted by IGIPES. EMD of successful bidder shall be released only after successful completion of the sale process.
6. In the event of acceptance of Tender, the successful bidder shall be required to deposit full amount in the shape of Demand Draft (DD) drawn in favour of the **Principal, IGIPES** payable at New Delhi within 04 days from the issue of order, failing which the sale order shall be cancelled and EMD will be forfeited.
7. The Vehicle will be delivered only after the receipt of full payment and has to be lifted by the bidder at his/their own expenses within 04 days of completion of deal failing which ground rent at the rate of Rs.500/-per day will be charged.
8. The person authorized by bidder will be allowed to take the delivery on production of valid Identity proof along with the authority letter issued by the successful bidder. The authorized person is required to produce any of documents as documentary evidence acceptable as valid Identity proof.
9. EMD of unsuccessful bidders shall be returned within three weeks of the award of contract to successful party.
10. Disputes, if any, shall be subject to jurisdiction in the Court of Delhi only.
11. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
