## Notice Inviting Expression of Interest Applications/ Proposals for Structural Safety Audit of the Auditorium, Kirori Mal College, University of Delhi.

Principal, Kirori Mal College invites E.O.I. Applications/ proposals, from approved & licensed Structural Consultancy Firms/Consultants for conducting Structural Safety Audit of the Auditorium, Kirori Mal College, University of Delhi, Delhi-110007. Only Consultants/ Firms who have the valid Licence of North Delhi Municipal Corporation for conducting Structural Safety Audit of buildings are eligible for submitting their EOI proposal for Kirori Mal College buildings. The Tender document can be downloaded from the college website and the Delhi University website.

The scope of work involves the following:

- 1. Study of site and drawings of the Auditorium available with the college.
- 2. To conduct visual inspections for assessment of present health of different structural members, including conducting Non-destructive tests at the site required for structural safety Audit.
- 3. Rapid Visual screening as per IS 13935-2009 & IS-988-2013
- 4. To study & identify structural defects, marking of critical areas & taking photographic evidence and measurements as required.
- 5. To check the health of reinforcements in RCC members. The current capacity of Foundations & load bearing walls etc. is required to be ascertained.
- 6. To obtain samples for lab tests from different structural members, getting required lab tests conducted under supervision done and obtaining the test results.
- 7. To carry out structural analysis based on latest building norms and applicable BIS Codes.
- 8. To locate cracks, leaking pipes, embedded services, & other defects in the buildings a f f e c t i n g structural safety.
- 9. To conduct any other test required for investigation as per latest codes for Structural Safety Audit.
- 10. If need is felt, then attending the Building Committee meeting for submission of the Final Structural Safety Audit Report and handling any further clarifications required by the college authorities.
- 11. Any other related work not specifically mentioned but required for satisfactory conducting of the Safety Audit as per North Delhi Municipal Corporation building norms and guidelines.

The proposals shall include details of the applicant & experience, the list of qualified staff

proposed to be deployed, along with the list of tests & equipment/s for site tests & taking samples. Copies of Pan Card and GST registration certificate must be submitted along with the

list of material testing labs from which samples are proposed to be tested. Total cost of work

and stages of payments of bills must also be submitted. The proposal shall also include the

time period for undertaking the study and submission of the final report.

E.O.L. applications/proposals in sealed cover must be submitted in the office of Principal

Kirori Mal College, by 28.06.2021 before 12:00 noon. These shall be opened on the same

day at 12.30 p.m. in presence of intending applicants.

Before submitting the proposal, the applicants, at their own cost, may inspect the Auditorium

at Kirori Mal College on working days between 10:00 a.m. to 4:00 p.m. with prior

appointment with the Caretaker on Whatapp or phone at 8800638945.

The proposal/quotation shall mention the rate payable per square meter, inclusive of all

charges for the area 1040 sq.m. The rate quoted shall be inclusive of all operations and equipment required for site and laboratory tests, analysis of test result and preparation and

equipment required for site and indocatory tests, analysis of test result and preparation and

submission of the Structural Safety Report along with the recommendation/s. GST @ 12%

shall be payable extra.

Three copies of the Safety Audit Report shall be submitted within a period of 04 weeks from

the date of the issue of Work Order.

Final payment will be made after the acceptance of the Structural Safety Audit Report by the

competent authority of the college.
